### Guidelines when filling the EUC

Please note that the lack of any of these will make us go back to you to get the customer to fill it out appropriately:

- A scanned copy is fine as long as it has a signature on it.
- Signing parties must have signatory authority for their company (preference being given to someone from Legal or Trade Compliance for that company).
- Language on this document should not be revised. Where a customer is unable to sign with the existing language they should send Intel a redlined copy of their changes for our review and approval.
- An original signed copy does not need to be sent to us.
- Must be on **company letterhead** and does not require the company stamp.
- Besides the Company Legal Address, please also list in the EUC any addresses to where the customer will potentially ship. If there is more than one, please list them at the end of the form (page 2). Please consider that if there is a shipment with an address that is not showing on the EUC, that location is not going to be covered by the certificate. This includes any subsidiaries, domestic/in-country sites, and customers of the customer themselves.
- Information needs to be in English.
- This EUC expires to 2 year after date of signature.

## INTEL END USER CERTIFICATE (EUC) FORM

Intel Products are subject to export controls under the laws and regulations of the United States and other applicable governments as required. Intel Products include without limitation hardware, software, technical data, servicing, support and training.

Without prior authorization from the U.S. Government and/or other applicable governments as required we certify:

- Not to export/re-export/transfer/sell/resell Intel Products if they will be or are intended to be used for a military end-use or by a military end-user of the following countries listed in the Export Administration Regulations (EAR) D1 or D5 country list: Afghanistan, Armenia, Azerbaijan, Belarus, Burma, Cambodia, Central African Republic, China, Cuba, Cyprus, Democratic Republic of Congo, Eritrea, Georgia, Haiti, Iran, Iraq, Kazakhstan, Kyrgyzstan, Laos, Lebanon, Libya, Macau, Moldova, Mongolia, North Korea, Russia, Somalia, Sudan, South Sudan, Syria, Tajikistan, Turkmenistan, Ukraine, Uzbekistan, Venezuela, Vietnam, or Zimbabwe.
- Not to process or incorporate Intel Products and technology into secondary products, including supercomputers, which contribute to the design, development, manufacture, production, testing, stockpiling or use of any nuclear, chemical, or biological weapons.

We also certify:

- That we are not a party designated under U.S or EU Sanctions.
- That we are neither owned nor controlled by a designated party under U.S or EU Sanctions.
- That the answers we have provided remain applicable and extend to any order or purchase where we request Intel to export the Product directly to another organization on our behalf.
- That we will notify Intel of any changes to these responses. ([export.customer@intel.com](mailto:export.customer@intel.com)).
